Terms & Conditions



Participation

- 2. All entry instructions and prize information published by the Promoter form part of these terms and conditions. By entering the Competition, entrants accept these terms and conditions.
- 3. The Competition commences at 07:00 AM on Monday, 27 March 2023 and closes at 11:30 AM on Tuesday, 28 March 2023 ("Entry Period"). Unless otherwise stated, all times are Australian Western Time.

Prize Winner
